## Nursery Admission Policy

### 2026-2027

This school is committed to safeguarding and promoting the welfare of children and young people/vulnerable adults and expects all staff and volunteers to share this commitment.

# Admission Arrangements for Squirrel Hayes Nursery 2026-2027

Your child can join our nursery for 15hrs free nursery education from the term after their 3<sup>rd</sup> birthday. We run a cycle of 3 term admissions:

- September
- January
- April

There are 26 places available overall for the 3 points of entry to our Nursery.

It is our policy to try and meet parents' wishes where possible, however in some cases there may be more applications for a particular intake than there are places and in this instance admission to Nursery will be determined by the oversubscription criteria detailed below.

## Oversubscription Criteria

If the total number of applications for admission to the Nursery setting exceeds the number of available places, then the following order of priority will be used to allocate the available places.

- 1) Children in care and children who ceased to be in care because they were adopted (or became subject to a child arrangements order or special guardianship order), including those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted
- 2) Children who satisfy both of the following tests:

Test 1: the child is distinguished from the great majority of other applicants either on their own medical grounds which requires regular and sustained medical treatment or by other extreme exceptional circumstances.

Medical grounds must be supported by a medical report (obtained by the applicant and provided at the point of application). This report must clearly justify, for health reasons only, why it is better for the child's health to attend the school rather than any other school.

This school is committed to safeguarding and promoting the welfare of children and young people/vulnerable adults and expects all staff and volunteers to share this commitment.

Exceptional circumstances must relate to the choice of school and the individual child, i.e. the circumstances of the child, not the economic or social circumstances of the parent/carer. They should be supported by a recent professional's report (obtained by the applicant and provided at the point of application), e.g. social worker. This report must clearly explain why the child's circumstances are exceptional and why it is considered best that they attend the school rather than any other school.

Test 2: the child would suffer hardship if they were unable to attend the school.

Hardship means severe suffering of any kind, not merely difficulty or inconvenience, which is likely to be experienced as a result of the child attending a different school. Applicants must provide detailed information about both the type and severity of any likely hardship at the time of application

- 3) Children who have an elder sibling in attendance at the school and who will still be attending the school at the proposed admission date; (for admission purposes, the children/ siblings must be living at the same home address for the majority of the school week and either: have one or both natural parents in common; are related by a parents marriage; are adopted or fostered by a common parent or are unrelated children who live at the same address, whose parents live as partners.)
- 4) Children living within the catchment area of the school.
- 5) Children of staff in either or both of the following circumstances:
  - a) where the member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made, and/or
  - b) the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.
- 6) Other children arranged in order of priority according to how near their home addresses are to the main gate of the school, determined by a straight-line measurement as calculated by the Local Authority's Geographical Information System.

Where it is not possible to accommodate all children applying for places within a particular category then the Governors will allocate the available places in accordance with the

remaining criteria. If for instance, all the catchment area children cannot be accommodated at the school, children who are catchment area children and satisfy category (3) will receive offers of a place, followed by children who live in the catchment area and satisfy category (4), etc.

### How to apply

The closing date for nursery applications will generally be the Friday before every half term, for a start date of the following term. Application forms are available on the school website, via the school office and a copy attached as Appendix A.

#### January Intake: (2027):

If your child is 3 years old by 31<sup>st</sup> December 2026, they are eligible to start our Nursery setting in January.

Please apply by 1<sup>st</sup> October 2026 .

#### April Intake: (2027)

If your child is 3 years old by 31<sup>st</sup> March 2027, they are eligible to start our Nursery setting after the Easter half term break.

Please apply by 1<sup>st</sup> February 2027.

#### September Intake: (2027)

If your child is 3 years old by 31<sup>st</sup> August 2027 they are eligible to start our Nursery setting in September.

Please apply by 1<sup>st</sup> May 2027.

Parents will be notified of the outcome of their application 4 weeks after the closing date.

### Additional Notes

Attendance at the nursery will not guarantee admission to our Reception Class or give any advantage to the child's application for Reception. Parents must reapply for admission to Reception at the appropriate time through their Home Local Authority.

In accordance with legislation, children who have an Education, Health and Care Plan that names the nursery will be admitted to our Nursery setting. This may reduce the number of places available to other applicants.

Relevant Children in Care means children who are in the care of a local authority in accordance with section 22 of the Children Act 1989(b) and who (a) are looked after at the time an application is made and (b) in relation to whom the local authority has confirmed that the children will still be looked after at the time when the child will be admitted to school. It has also recently been extended to include those previously determined as Looked After

Children. (That is, children who were looked after but ceased to be so because they were adopted (or became subject to a residence order or special guardianship order).

The home address is considered to be the child's along with their parent/carers main and genuine principal place of residence at the time of the allocation of places i.e. where they are normally and regularly living. If a child is resident with friends or relatives (for reasons other than legal guardianship) the friends or relatives address will not be considered for allocation purposes.

Where parents have shared responsibility for a child, and the child lives with both parents for part of the school week, parents will be required to provide documentary evidence to support the address they wish to be considered for allocation purposes.

If there are a limited number of spaces available and we cannot distinguish between applicants using the criteria listed, such as in the case of children who live in the same block of flats or are the result of a multiple birth, then the child or children who will be offered the available spaces will be randomly selected by drawing lots.

Unsuccessful applicants will be placed on a waiting list in accordance with the oversubscription criteria stated above. If places become available after the offer date they will be offered to the child at the top of the waiting list.

There is no statutory right of appeal for admission to a nursery setting. Any disputes over the administration of the policy will be dealt with by the Governor's complaints procedure.

### **30 Hours Childcare**

Working parents in Staffordshire could receive 30 hours a week of funded childcare for their 3 and 4 year old children. The 30 hours childcare offer doubles the existing 15 hours of childcare funding currently available through Squirrel Hayes First School Nursery.

Squirrel Hayes First School work in partnership with Space Cadets who have an out of school provision and a pre-school setting based on the school site. Children can attend Squirrel Hayes First School in the morning and then can transfer to 'Space Cadets' pre-school for their afternoon sessions which is based in the same Foundation Stage Building. As stated above, parents may receive this additional afternoon care free of charge if they meet a certain criteria. Parents that do not meet the criteria have the option to pay for additional nursery care in the afternoon should you wish for your child to attend additional nursery sessions.
